- Mr. Drahi is the sole controlling shareholder of Uppernext S.C.S.p ("Uppernext"). As such, Mr. Drahi may be deemed to beneficially own shares of the Issuer held by

  (3) Uppernext A4 S.A. which is controlled by the family of Mr. Drahi is an executive board member of Altice Europe N.V. Mr. Drahi is a director of the Issuer and Next
